

Instruction for M.Tech Admission- 2017

At the time of reporting, all candidates have to produce their original testimonials for verification and submit self-attested photocopies of all the required documents (a complete list of documents is given below), failure to do so may result in automatic cancellation of admission:

1. Allotted Institute Admission Letter.
2. Payment of fee mode of Demand draft.
3. GATE score card in original.
4. High School/Secondary School certificate of the Board/University specifying the date of birth.
5. Grade/Mark Sheets of qualifying degree examination for all semesters.
6. Degree/ Provisional Certificate.
7. Certificate for having passed the qualifying examination. If it is not possible, a letter from the Head/ Registrar of the Institute indicating that you have appeared in the final qualifying examination must be produced. Last date for submission of such certificate is September 15, 2017.
8. Migration Certificate from last Institute/University attended.
9. Conduct Certificate and Transfer Certificate from head of the institution last attended
10. Two copies of recent passport size photograph.
11. Medical Certificate of fitness from the doctor, not below the rank of Senior Medical Officer in **prescribed format**.
12. No objection certificate or a relieving certificate from your employer in case you are currently employed.
13. A caste certificate (Including non-creamy layer status for OBC candidate) issued by a competent authority in the prescribed format as stipulated by Government of India, in case you belong to SC, ST and OBC community.
14. An undertaking for non-creamy layer status for OBC candidates.
15. An anti-ragging affidavit in **prescribed format**.
16. Aadhaar Card.
